The FBI does not retain noncriminal justice fingerprint submissions for those applying for license or employment purposes pursuant to Public Law 92-544.

Your social security number is required to keep records accurate because other people may have the same name and date of birth. See, Privacy Act of 1974 (Public Law 93-579). Federal Executive Order 9397 requests federal agencies to use this number to help identify individuals in agency records.
